Discussion of curriculum for instruction to meet the requirement of Senate Bill 9

Shelly Weber shared that the SHAC is required to review and vote on a curriculum of instruction addressing child abuse, dating violence and sex trafficking. There has been discussion at the last couple of meetings. The recommendation that was discussed at the January 9, 2023 meeting is as follows:

Elementary—Child abuse education, Speak Up Be Safe, presented by the Center for Child Protection in grades 3, 4, 5.

Middle School—Dating violence, family violence and sex trafficking, Living Well Aware in grade 6 and Big Decisions in grade 7 or 8. Goodheart Willcox textbook to cover health TEKS not covered in these two curriculum.

High School—Dating violence, Healthy Relationships as presented by the Hays Caldwell Women's Center staff in grade 9, Family violence curriculum as presented by the Hays Caldwell Women's Center in grade 10.

In addition, 2-3 times a year during certain awareness months the district would like to have booth displays to reinforce these topics. (January-Human Trafficking Awareness Month, February-Teen Dating Violence Prevention Month, April-Sexual Assault and Child Abuse Prevention Month, October-Domestic Violence Prevention Month)

Ty Davidson stated that the Goodheart Willcox textbook is online. He also stated that there was a presentation last week to review the curriculum in the textbook.

Vote for curriculum for instruction to meet requirements for Senate Bill 9

Jackie Keller made the motion to use the Hays Caldwell Women's Center curriculum as presented at the high school level as recommended, Nicole Burnett seconded the motion. All members voted in favor of the motion: Lezlie Baltierra, Ken Elliott, Bethany Estrada, Joshua Gilbert, Denise Manibusan, Sheri Moebes, Maria Rios, Lenaya Robinson, Shelly Weber. The motion passed unanimously.

Lenaya Robinson made the motion to use the Center for Child Protection Speak Up Be Safe curriculum as presented for grades 3, 4 and 5. Sheri Moebes seconded the motion. All members voted in favor of the motion: Lezlie Baltierra, Nicole Burnett, Ken Elliott, Bethany Estrada, Joshua Gilbert, Jaclyn Keller, Denise Manibusan, Maria Rios, Claudia Valle, Shelly Weber. The motion passed unanimously.

Nicole Burnett made the motion to use Living Well Aware for grade 6 and Big Decisions for grade 7 or 8 and the Goodheart Willcox textbook to cover the curriculum requirement as presented. Jackie Keller seconded the motion. All members voted in favor of the motion: Lezlie Baltierra, Ken Elliott, Bethany Estrada, Joshua Gilbert, Denise Manibusan, Sheri Moebes, Maria Rios, Lenaya Robinson, Claudia Valle, Shelly Weber. The motion passed unanimously.
